Specifications modified to include requirements for Cluster of Saplings as follows:

Section 6.0(D) Cluster saplings is the term used for an area of any nuisance tree saplings too small to reasonably measure (typically than 1 DBH or less). The Cluster Saplings are to be removed at a point flush with the ground surface. All trees in the designated cluster Saplings area shall be removed and disposed in same fashion as larger trees. The stump of the sapling need not be removed. Cluster Sapling area will be identified by the city representative.

Apologize for pre-bid meeting issues. My presence was required an emergency meeting. Those that attended in person had few questions and the only issue of merit was the cluster of saplings.
