SPECIFICATIONS FOR 2023 CRACK SEALING AND JOINT SEALING

<u>Base Project</u>: Crack Sealing of approximately <u>146,460 SY</u> of Asphalt Surfaced Streets in the City of Fort Pierre.

<u>Alternate Project</u>: Joint Sealing 12,790 SY of Concrete Surfaced Streets in the City of Fort Pierre.

The successful bidder is to furnish and install the Crack Sealant and Joint Sealant in accordance with the SDDOT standard Specifications with exceptions noted.

Base Project:

Contractor will be responsible clean, dry and prepare the cracks to receive the sealant.

Contractor is responsible for furnishing and installing the sealant.

Contractor will be responsible for all equipment, signing, brooming, pilot car, etc. to complete the Crack Sealing.

Contractor is responsible for brooming streets of routing and cleaning debris prior to opening streets to traffic.

Contractor shall provide copies of Insurance and Worker Compensation.

The SD DOT 2015 Standard specifications Section 350 will be used as a guideline for placement and material specifications. Section 871 shall apply to contractor furnished materials.

Modifications to SDDOT Standard Specifications are as follows:

Routing of Cracks less than 1/2" shall be routed to a width of 1/2" and depth of 3/4". Cracks greater than 1/2" shall not be routed.

Cracks between asphalt surfacing and concrete curb, driveway or concrete pavements shall be cleaned and sealed as specified.

Seasonal limitations revised to: Routing and Crack sealing of Asphalt concrete surfaces will be permitted only during daylight hours between January 1 and June 1, when air temperature is above 40 Degrees Fahrenheit and no precipitation anticipated for 48 hours after application of sealant.

The quantity includes streets to receive asphalt surface treatment in 2023 and other streets to be only crack sealed. Streets receiving Asphalt Surface Treatment in 2023 shall be completed first then other streets listed.

Final streets will be determined, and final price adjusted prior to issuance of the contract, information will be provided by City, and contractors will agree to all terms and conditions set forth by the City.

Base Project Work to be completed by June 1, 2023. Liquidated Damages of \$250 per day may be assessed.

Alternate Project:

Contractor will be responsible clean, dry and prepare the Joints to receive the sealant. Joints between curb and pavement are to be sealed.

Contractor is responsible for furnishing and installing the sealant.

Contractor will be responsible for all equipment, signing, brooming, pilot car, etc. to complete the Joint Sealing.

Contractor is responsible for brooming streets of cleaning debris prior to opening streets to traffic.

Contractor shall provide copies of Insurance and Worker Compensation.

The SD DOT 2015 Standard specifications Section 380 will be used as a guideline for placement and material specifications. Section 870 shall apply to contractor furnished materials.

Final quantities will be determined prior to issuance of the contract, information will be provided by City, and contractors will agree to all terms and conditions set forth by the City.

Alternate Project Work to be completed by October 1, 2023. Liquidated Damages of \$250 per day may be assessed.

The crack sealing and joint sealing will be applied at various locations around the city of Fort Pierre. Attached is a list and a map of the streets expected to receive crack sealing and joint sealing at time of the bid. Final locations for work will be determined prior to issuance of the contract.
