City of Fort Pierre (Owner) is requesting Bids for the construction of the following Project:

2025 Street Improvements Engineer's Project No. 31942

Bids for the construction of the Project will be received at the City Hall located at 08 East 2nd Avenue, Fort Pierre, South Dakota, until Wednesday, February 12th at 3:00 p.m., central local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

- Dupree Trail: Removal of existing surfacing, granular base, and curb & gutter. Grading, placement of granular base, new curb & gutter, pavement, and other associated work.
- Benjamin Street: Removal of portion of the existing surfacing and granular base. Milling of a portion of the existing surfacing. Installation of new granular base, pavement, and other associated work.
- 200 Block North 6th Street: Removal of existing asphalt surfacing, granular base and curb & gutter, grading; installation of granular base, curb & gutter, pavement, and other associated work.

Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including addenda, if any, obtained from sources other than the Issuing Office.

Bidding Documents may be downloaded online at the designated website. Resident South Dakota contractors who intend, in good faith, to bid upon this project may obtain a paper set of these documents free of charge. Non-resident contractors may receive these documents upon payment of \$100.00, none of which is refundable.

Construction services in South Dakota are subject to tax under SDCL 10-46A. Contractors shall include the applicable tax in their bid price for each item of work. Tax questions should be directed to the South Dakota Department of Revenue at 800-829-9188.

Bid shall be submitted on the prescribed form.

The submittal of the Bid will constitute an incontrovertible representation by Bidder that the Bidder has examined carefully the bidding documents, visited the site, is familiar with the local conditions under which the work is to be performed, and correlated bidder's observation with the requirements of the bidding documents.

Each bid must be accompanied by Bid Security as specified in the bidding documents. Successful bidder shall begin the Work on receipt of the Notice of Proceed and shall complete the Work within the Contract Time.

The City of Fort Pierre reserves the right to retain the bid security of the three lowest bidders for a period not to exceed 30 days after the date and time set for opening of the bids. The City of Fort Pierre reserves the right to reject any and all bids or any parts thereof.
