

NOTICE OF CALL FOR BIDS

The City of Fort Pierre, South Dakota, will receive FIRM sealed bids at the City of Fort Pierre, P.O. Box 700, Fort Pierre, South Dakota, 57532-0700, up to 10:00 AM Central Time, April 2, 2015, to complete the **"2015 Street Improvement Project"** for the City of Fort Pierre. This project consists of rebuilding surfacing, undercut base, digouts, and select curb and gutter replacement on the 700 block of Casey Tibbs Street South, 600–1000 blocks of LaFramboise Drive, 700 block of Two Rivers Street, and the 300 block of Main Avenue West.

Paper copies for contractor's use are also available upon request, and non-refundable payment of \$50.00 for each set, from Wenck Associates Inc., (605) 222-1826. If Plans are to be mailed an additional fee of \$25.00 will be added for postage and handling. Additionally, upon request and in accordance with South Dakota Codified Law 5-18B-1, one copy of the Plans and Specifications shall be furnished, without charge, to each Contractor resident in South Dakota who intends, in good faith, to bid on the project.

The City of Fort Pierre reserves the right to accept or reject any or all BIDS, to waive any informality in the BIDS received, and to accept the BID that is to the advantage and in the best interest of the City of Fort Pierre.

Each bid must contain a certified check equal to five percent (5%) of the highest bid total. Such a check is to be certified or issued by either a State or National Bank and made payable to the City of Fort Pierre. In lieu of a certified check, the contractor may include a Bid Bond equal to ten percent (10%) of the highest bid total. The bid bond shall be issued by a Surety authorized to do business in the State of South Dakota and made payable to the City of Fort Pierre as a guarantee that such bidder will enter into a contract with the City of Fort Pierre in accordance with the terms of this bid letting and if such bidder is awarded the contract. The certified check, or other guarantee, or bid bond of the successful bidder, will be returned to him forthwith upon the execution of a contract and surety hereafter provided for. The Contractor shall also provide proof of liability insurance and workman's compensation insurance.

Bids shall be marked **"2015 Street Improvement Project"** and sealed. The City of Fort Pierre requests one (1) Original Bid and one (1) copy. Bids may be mailed to the City of Fort Pierre, P.O. Box 700, Fort Pierre, South Dakota, 57532-0700 or hand delivered to the Office of the Finance Officer, 08 East 2nd Ave., Fort Pierre, South Dakota 57532.
