

ORDINANCE NO. 1006

AN ORDINANCE PROVIDING SUPPLEMENTAL APPROPRIATION FOR THE CITY OF FORT PIERRE, SOUTH DAKOTA FOR FISCAL YEAR 2016.

BE IT ORDAINED by the City Council, in and for the City of Fort Pierre, South Dakota:
