## FORT PIERRE CITY COUNCIL APPROVED MINUTES

REGULAR MEETING Monday, October 7, 2019

The regular meeting of the Fort Pierre City Council was called to order by Mayor Hanson at 6:30 pm. Members present for Roll Call were Cronin, Kenzy, Ricketts, and Weisgram. Bernhard and LaRoche were absent. Officials present were Cromwell, Hahn, Heezen, and Tibbs.

**Approval of Agenda.** Weisgram moved and Kenzy seconded to approve the agenda as amended. Motion passed on Voice Vote.

**Conflict of Interest Declarations.** No conflict of interest declaration was declared.

**Reports.** 1.) Heezen informed council that the August cash report was included in the packet. 2.) Heezen reported that Sales Tax through August sales was up 4.23% YTD, BBB was up .5% YTD, and Occupancy Tax was up 13.52% YTD. 3.) Heezen informed council a claim has been sent to insurance on the WW Tire waterline issue. 4.) Hahn informed council that a public service announcement had been sent out regarding the ordinance on sump pumps and the need to get a permit to discharge into sanitary sewer requirements. 5.) Hahn reported that COE is currently discharging around 61,000 CFS and plans to continue this until late November and they are also doing a public meeting at the Casey Tibbs Rodeo Center at 10 am on 10/23/19.

**Consent Calendar.** Weisgram moved and Kenzy seconded to approve the Consent Calendar items: Minutes: 9/16/19 meeting; Open Container Permit: Hoffert/Zilverberg wedding reception at Pat Duffy Community Center 11/23/19. Motion passed on Voice Vote.

**Public Hearing.** Mayor Hanson opened a public hearing at 6:38 pm for the purpose of getting public input on the Temporary Liquor License for the Casey Tibbs Rodeo Center Tribute Dinner on 11/2/19. Hanson asked for proponents to the license. She heard none. She asked for opponents to the license. She heard none. Hanson declared an end to the public hearing at 6:39 pm.

**Temp Liquor Lic-Casey Tibbs Rodeo Center-Tribute Dinner.** Ricketts moved and Kenzy seconded to approve the Temporary Liquor License for the Casey Tibbs Rodeo Center Tribute Dinner on 11/2/19. Motion passed on Voice Vote.

**Public Hearing.** Mayor Hanson opened a public hearing at 6:39 pm for the purpose of getting public input on a Petition to Vacate Public ROW. Hanson asked for proponents to the petition. Jayme Deis spoke on behalf of the petition stating that vacating the public ROW would provide access for development of Lots 1-3. Hanson asked for opponents to the license. She heard none. Hanson declared an end to the public hearing at 6:43 pm.

Res 2019-16 Petition to Vacate. The following resolution was presented:

RESOLUTION NO. 2019-16

A RESOLUTION VACATING THE PORTION OF THE ALLEY DESCRIBED AS 20' WIDTH OF ALLEY RIGHT OF WAY TO THE WEST SIDE OF LOTS 1-3 ON BLOCK 10 ON THE EAST SIDE AND, CORRESPONDINGLY, LOTS 44-46 ON THE WEST SIDE ON BLOCK 10, STANLEY TOWNSITE, CITY OF FORT PIERRE, STANLEY COUNTY, SOUTH DAKOTA.

WHEREAS, a petition to vacate the portion of the alley described as 20' width of alley right of way to the west side of Lots 1-3 on block 10 on the east side and, correspondingly, Lots 44-46 on the west side on Block 10, Stanley Townsite, City of Fort Pierre, Stanley County, South Dakota,

Having been filed in the office of the Finance Officer, and

WHEREAS, the City Council has caused two public notices in The Capitol Journal (9/20/19 and 9/27/19), a legal newspaper in and for the County of Stanley, State of South Dakota, notifying the public that on October 7, 2019 at 6:35 p.m. the time and place, when and where said petition was heard and considered by the Fort Pierre City Council, at which time the City was to investigate, consider and hear the testimony of all parties interested, and

WHEREAS, the City Council determined at its regular meeting on the 7th day of October, 2019 at 6:35 p.m. that the public interest would be better served by such proposed vacation of the public right-of-way in question, now therefore

**BE IT RESOLVED AND ORDERED,** that the alley in question being described as follows:

20' width of alley right of way to the west side of Lots 1-3 on block 10 on the east side and, correspondingly, Lots 44-46 on the west side on Block 10, Stanley Townsite, City of Fort Pierre, Stanley County, South Dakota, with the City retaining a 20'Utility Easement for the same location

Is hereby vacated pursuant to City Council's acceptance, which vacation shall take effect immediately and be subject to referendum as other resolutions pursuant to the South Dakota Compiled Laws of 1967, Chapter 9-45 as amended,

now therefore

**BE IT FURTHER RESOLVED AND ORDERED,** that the City Finance Officer shall file for record and duly record such vacation in the office of the Register of Deeds of Stanley County of South Dakota.

Weisgram moved and Ricketts seconded to approve Resolution 2019-16 Petition to Vacate as presented. Motion passed on Voice Vote.

**Public Hearing.** Mayor Hanson opened a public hearing at 6:50 pm for the purpose of getting public input on a Rezone from Agricultural to Multi Family Residence for Jayme Deis. Hanson asked for proponents to the rezone. Deis explained he is interested in building a two-level two unit condo with garages on his property. Hanson asked for opponents to the rezone. She heard none. Hanson declared an end to the public hearing at 6:50 pm.

**2<sup>nd</sup> (Final) Reading Ord 1033 Rezone Ag to Multi Family Res.** Weisgram moved and Kenzy seconded to approve the 2<sup>nd</sup> (Final) reading of Ordinance 1033-Rezone. Motion passed on Voice Vote.

**Approval of Contract-Seiler.** Hanson explained that this contract would increase efficiency in code enforcement for the City. Concerns of how it would affect current City Legal Counsel and funding were raised. Council requested to go into executive session to discuss contractual matters.

**Executive Session.** Ricketts moved and Kenzy seconded to enter into Executive Session at 7:10 pm pursuant to SDCL 1-25-2(3) for legal/contractual matters with legal counsel. Mayor Hanson declared an end to Executive Session at 7:29 pm.

**Approval of Contract-Seiler (continued).** Ricketts moved and Cronin seconded authorization for the mayor to enter into the contractual contract of Code Enforcement with Randy Seiler. Motion passed on Voice Vote.

**Quotes and Award for Demolition of residence at 310 E** 6<sup>th</sup> **Ave.** The following quotes were received: Morris Inc \$4,650.00; B&B Equipment \$8,000; Briggs Trucking \$4,540.82; Red River Construction LLC \$4600.00; Solbros Construction & Landscaping \$11,200. Ricketts moved and Kenzy seconded to accept Briggs Trucking quote in the amount of \$4540.82 with demolition to commence following the expiration of the court-ordered 30 day period the property owner has to object to the quotes (on or after 10/19/19). Motion passed on Voice Vote.
